- A ticket represents a chance to win the opportunity to accept an offer of the stated prize on these terms and conditions and, upon winning, those in the "Winner Notification Agreement," the terms of which are hereby incorporated by reference. If you hold a ticket or a receipt, your ticket has been entered in the raffle, subject to these terms and conditions. Winning tickets shall be selected by a drawing at random and all participants have an equal opportunity to win. Tickets, receipts and the winners' rights are not transferable. Winners need not be present at the drawing.
- Winners agree to accept all prizes in their "AS IS, WHERE IS" condition, subject to all latent and patent conditions, with absolutely no express or implied warranties of any kind by SJCRH.
- Each winner will be notified in writing in a Winner Notification Agreement, which will be sent by certified, return receipt U. S. Mail to the address provided by that winner. Each winner will have seven (7) days from the date of his/her receipt of the Winner Notification Agreement to accept the prize by executing and returning the Winner Notification Agreement pursuant to the terms stated therein.
